### **IMPORTANT INFORMATION ABOUT TEP'S ADMISSIONS LOTTERY (April 13, 2010)**

**The Equity Project (TEP) Charter School is a public school that is free for all students.** TEP has 120 seats for students entering 5<sup>th</sup> grade in September 2010. TEP anticipates that more than 120 students will submit applications to attend TEP. Therefore, TEP will hold a lottery to fill its 120 student 5th grade cohort.

Each prospective student will have one ticket entered into the lottery drawing. An individual unaffiliated with TEP will select tickets, one at a time, until all tickets have been drawn. After the lottery is completed, TEP will inform you as to whether your child has been awarded one of the 120 open seats at TEP. If your child is not awarded an open seat through the lottery, your child will be placed on a waiting list for future openings. TEP's lottery is open to *any student* residing in New York City who will be entering 5<sup>th</sup> grade in September 2010. However, admissions preference is given to students who reside in Community School District 6.

In addition, TEP has reserved at least 30% of its seats for students "at-risk" of academic failure. These are students who meet EITHER of the following criteria at the time of TEP's application deadline: (1) a student who scored a 1 or 2 on the most recent NY English Language Arts exam for which that student's score is available OR (2) a student who scored a 1 or 2 on the most recent NY Mathematics exam for which that student's score is available. **By submitting this application, you are expressly giving The Equity Project Charter School permission to access your child's NY City and NY State student records in order to verify your child's scores on all city and state standardized exams.**
